SUMMARY OF MEETING NOTES

1. Finalise Terms of Reference

- The revised draft SAP Terms of Reference (ToR) were discussed and the necessary adjustment made before being finalised and recirculated to the Group.
- Panel members and observers will seek internal sign-off on the ToR ahead of the face-to-face meeting in London on the 16th June.
- Further clarity on the time requirements of Panel members, as well as the distinction between Observer and Member status, was requested.
- A wording adjustment made to the ToR will reflect that the role of the Panel is advisory only, and not as a decision-making body. It was further agreed that:
 - Panel members are free to advise and make recommendations to IOI who, in turn, may choose to accept or reject this advice.
 - A diversity of views and advice among the Panel is to be expected and valued, reflecting the different perspectives being brought to the table.
 - Where there is diversity of perspective and advice, this will be recorded in the meeting minutes.
 - Panel members remain free to distance themselves from the Panel should they disagree with the advice being provided.

2. New Panel members

• Karimah Hudda, Global Sustainability Lead, Procurement, Mondelez International was welcomed to the Panel as a new member.

- Panel members now total five (2 NGO, 1 Industry Expert, 2 Customers). It was generally agreed that this reflects a good number and diversity and, whilst the door remains open to additional members (particularly where they would bring value) there will be no pro-active effort to recruit additional Panel members currently.
- The two remaining Panel members with observer status agreed to consider whether to move to full Panel membership. IOI suggested that there is little distinction between Observer and Member status given the Panel is advisory only.
- Oxfam's commitment to the Panel is for one-year only, after which they will have a formal internal review to decide whether or not to continue.
